

1. Requested Motion:

Meeting Date: March 15, 2010

Approve request for the "Ft. Myers Beach Kingfish Shootout" Special Event on March 26th-28th, 2010 to be held at Nervous Nellie's Crazy Waterfront Restaurant (formerly Snug Harbor Waterfront Restaurant) and the Town's Old San Carlos fountain area directly adjacent to Nervous Nellie's Crazy Waterfront Restaurant, and authorize open containers of alcohol at this event in the designated area of the three day fishing tournament as provided in Ordinance #99-15.

Why the action is necessary:

Council must approve all Special Event Permits for events involving alcohol.

What the action accomplishes:

Allows staff to issue the Special Event Permit and the applicant to move forward with the event.

5. Background:

The event will be a three day fishing tournament at Nellie's Crazy Waterfront Restaurant (formerly Snug Harbor Waterfront Restaurant) and the Town's Old San Carlos Fountain next to Nervous Nellie's Crazy Waterfront Restaurant. The special event will be held on Friday March 26th, 2010 and end on Sunday March 28th, 2010. The Town's fountain area will be utilized from 3:00pm to 8:00pm on Friday and 3:00pm to 7:00pm on Saturday and Sunday. Eight tables, one 12'x12' stage, and one 10'x10' sunshade will be placed in the fountain area adjacent to the restaurant. Nervous Nellie's Crazy Waterfront Restaurant will be obtaining a three day temporary extension of premises permit for the sale of alcoholic beverages at this event. The fishing tournament will run from 3:00pm-8:00pm on Friday March 26th, 7:00am-7:00pm on Saturday March 27th, and 7:00am-7:00pm on Sunday March 28th. 




