RESOLUTION NUMBER 98- 26

A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, FLORIDA, CERTIFYING THE RESULTS OF THE ELECTION; CANDIDATES FOR SEAT TWO; CANDIDATES FOR SEAT THREE; CANDIDATES FOR SEAT FOUR; CANDIDATES FOR SEAT FIVE; DECLARATION AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Charter requires periodic elections for membership on the council and the council called an election in the Town of Fort Myers Beach, to be held the 3rd day of November, 1998, for the purpose of having all of the qualified electors within the Town to determine the members of the council for seats #2, #3, #4 and #5.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA:

Section 1. Certificate of results of Election. There is hereby certified that the appropriate election officials have canvassed the ballots and certified same to the Lee County Supervisor of Elections and the Supervisor has in tern, certified the election results to the Town of Fort Myers Beach Council.

Section 6. Declaration. The Town Council hereby declares ANITA T. CERECEDA elected as Council member Seat #3, GARR REYNOLDS elected as for Council member Seat #4, and RAY MURPHY elected as for Council member Seat #5, and that there shall be a run off election on December 1, 1998, between LENA HEYMAN and DANIEL HUGHES to determine Council member Seat #2.

Section 7. Effective Date. This resolution shall take effect immediately upon its adoption by the Fort Myers Beach Town Council.


