RESOLUTION NUMBER 05-40

A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, FLORIDA, CERTIFYING THE RESULTS OF THE ELECTION; CANDIDATES FOR SEAT THREE; CANDIDATES FOR SEAT FOUR; CANDIDATES FOR SEAT FIVE; DECLARATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Charter requires periodic elections for membership on the council. Pursuant thereto, the Town Council of the Town of Fort Myers Beach, Florida called an election in the Town of Fort Myers Beach, which was duly held on the 8<sup>TH</sup> day of November, 2005, for the purpose of having all of the qualified electors within the Town determine the members of the Town Council for seats #3, #4 and #5.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA:

Section 1. Certification of Results of Election. There is hereby certified that the appropriate election officials have canvassed the ballots and certified same to the Lee County Supervisor of Elections and the Supervisor has in turn, certified the election results to the Town Council of the Town of Fort Myers Beach, Florida.

Section 2. Candidates For Seat Three. The votes received by the candidates for Council member Seat #3, are as follows: Total votes cast: 2,334

DENNIS C. BOBACK	<u>1,303</u>	<u>55.83%</u>
RAY MURPHY	<u>1,031</u>	<u>44.17 %</u>

Section 3. Candidates For Seat Four. The votes received by the candidates for Council member Seat #4, are as follows: Total votes cast: 2,326

KEN KATCKO	<u>982</u>	<u>42.22%</u>
BILL SHENKO, JR.	<u>1,344</u>	<u>57.78%</u>

Section 4. Candidates For Seat Five. The votes received by the candidates for Council member Seat #5, are as follows: Total votes cast: 2,175

CHARLES R. MEADOR, JR.	<u>1,235</u>	<u>56.78%</u>
W.H. "BILL" VAN DUZER	<u>940</u>	<u>43.22%</u>

Section 5. Declaration. The Town Council hereby declares Dennis C. Boback elected as Council member for **Seat #3**, Bill Shenko, Jr. elected as Council member for **Seat #4**, and Charles R. Meador, Jr elected as Council member for **Seat #5**.

Section 6. Effective Date. This Resolution shall take effect immediately upon its adoption by the Town Council of the Town of Fort Myers Beach Town.


