

RESOLUTION OF THE TOWN COUNCIL OF
THE TOWN OF FORT MYERS BEACH, FLORIDA
RESOLUTION NUMBER 07-36

A RESOLUTION OF THE TOWN OF FORT MYERS BEACH, FLORIDA, ADOPTING THE
FINAL TOWN OPERATING BUDGET FOR FISCAL YEAR 2007/2008, PROVIDING
AUTHORITY; TOWN MANAGER'S RESPONSIBILITY; FINAL BUDGET; PUBLIC HEARING;
ADOPTION; SEVERABILITY; REPEALING CLAUSE; AND EFFECTIVE DATE.

WHEREAS, Florida Statute 200.065(2)(c) establishes the method for determining and levying an ad valorem millage rate and adopting a budget for all taxing authorities in the State of Florida; and

WHEREAS, Florida Statute 166.241 requires the governing body of each municipality in Florida to adopt a budget via ordinance or resolution before the start of each fiscal year; and

WHEREAS, Article XI, Section 11.03 of the Town Charter provides for adoption of the budget by resolution on or before the 30th day of September of each year; and

WHEREAS, the Town of Fort Myers Beach, by and through its Town Council, hereby determines that it is in the best interest of the Town and orderly governmental process to hold public hearings as required by the aforesaid state statutes and Town Charter provisions; and

WHEREAS, following due notice, on September 24, 2007, the Town Council held the required public hearing and, following public input, adopted a final Town operating budget for fiscal year 2007-2008 which sets forth appropriations and revenue estimates in the amount of eighteen million, three hundred ninety-seven thousand four hundred ninety-nine dollars (\$18,397,499.00) dollars for fiscal year 2007-2008.

IT IS HEREBY RESOLVED BY THE TOWN OF FORT MYERS BEACH, FLORIDA AS FOLLOWS:

SECTION ONE: Authority. This Resolution is enacted pursuant to the provisions of Chapter 95-494, Laws of Florida, Chapter 166, Florida Statutes, and other applicable provisions of law.

SECTION TWO: Town Manager's Responsibility. The Town Manager of the Town of Fort Myers Beach, Florida, has presented to the Town Council the final operating budget covering the revenues and expenditures as estimated to be required for the fiscal year 2007/2008.

SECTION THREE: Final Budget. The Town Council, in duly called sessions, has reviewed the budget and, having made any necessary amendments thereto, has adopted a final budget which sets forth the appropriations and revenue estimates in the amount of eighteen million, three hundred ninety-seven thousand four hundred ninety-nine dollars (\$18,397,499) dollars for Fiscal Year 2007-2008. A copy of the final budget with any necessary amendments made by the Town Council during its meeting is attached hereto as Exhibit "A" and incorporated herein by reference.

SECTION FOUR. Consistency with the Town Comprehensive Plan. Following review of the report of the LPA as contained in the LPA Resolution 2007-17, the Town Council hereby finds that the proposed 2007-2008 Town capital improvement program (CIP) is consistent with the Town Comprehensive Plan as required by Plan Policy 11-A-1 and Policy 11-A-2(iii).

SECTION FIVE: Adoption. The Town of Fort Myers Beach, Florida, final operating budget, revenue, expenditures, and capital budget for the fiscal year 2007/2008, which is attached hereto as Exhibit "A", is hereby adopted.

SECTION SIX: Severability. If any one of the provisions of this resolution should be held contrary to any express provision of law of contrary to the policy of express law, although not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be deemed separate from the remaining provisions of this resolution, and in no way affect the validity of all other provisions of this resolution.

SECTION SEVEN: Effective Date. This resolution shall become effective immediately upon adoption.




