

RESOLUTION OF THE LOCAL PLANNING AGENCY OF
THE TOWN OF FORT MYERS BEACH, FLORIDA
RESOLUTION NUMBER 2009-30

WHEREAS, the existence of the Town of Fort Myers Beach Local Planning Agency (LPA) is mandated by Florida Statutes Section 163.3174 and the LPA was established in accordance with the requirements of the Town of Fort Myers Beach Land Development Code section 34-111 et seq.; and

WHEREAS, it is the role of the LPA to coordinate with the Town Manager of the Town of Fort Myers Beach in accomplishing the LPA's statutory tasks and to assist the Town Manager upon request; and

WHEREAS, as Jack Green has served as Town Manager for the Town of Fort Myers Beach from July, 2009 through the current time and has advised the Town Council that he intends to resign from that position, effective on February 12, 2010; and

WHEREAS, prior to his service as Town Manager, Mr. Green served as the Town Public Works Director and in various capacities within the Community Development Department as well as serving as a distinguished member of the Anchorage Advisory Committee prior to joining the Town staff.

1. Jack Green has shown superb dedication to the Town of Fort Myers Beach. He has been a wonderful representative of the Town and the taxpayers, and one of the most dedicated civil servants that the LPA has worked with.
