



NOTICE OF INTENT TO AWARD

MATANZAS HARBOR DINGHY DOCK REPAIRS ITB 19-15-PW

NOTICE IS HEREBY GIVEN that the Town Manager intends to recommend to the Town Council at their August 5, 2019 meeting, that the award of the above-referenced bid be made to the lowest responsive and responsible bidder, **KELLY BROTHERS, INC.**

A copy of this Intent to Recommend Award as well as the Bid Tabulation Sheet is posted on the Town of Fort Myers Beach web site, www.fmbgov.com

Any person who is adversely affected by this recommended action must file a written Notice of Bid Protest with the Town Clerk within seventy-two (72) hours (excluding Saturdays, Sundays and Legal Holidays) after the posting of the bid tabulation or after receipt of the Notice of Intent to Recommend Award, whichever is later. A formal written protest must then be filed within ten (10) days after the filing of the initial written Notice of Bid Protest. The formal written protest must state with particularity the facts and law upon which the protest is based. Failure to file a Notice of Protest or failure to file a formal written protest within the time limits set forth herein shall constitute a waiver of the right to protest. Any person filing a protest must post a bond, payable to the Town of Fort Myers Beach, in an amount equal to five percent (5%) of the total bid or Twenty Thousand Dollars (\$20,000), whichever is greater, but not to exceed the value of the bid. (Town Ordinance 17-01).
