5. Background:

Town Council adopted Ordinance 12-04 setting new regulations associated with special events held within the Town. This ordinance provides for events of a recurring nature to be permissible and administered through one permit not to exceed a twelve month duration. For an event to qualify for this type of permit the activity must be the same type of event, held in the same location, on the same day and time with similar attendance and the same genre.

This event meets the standards of the recurring special event as provided in Ordinance 12-04. The event organizer has made an application for the event to be held each and every Saturday starting November 24, 2012 through May 25, 2013 between the hours of 7:30 AM – 12:00 PM EST and 4:00 PM – 8:00 PM EST. The applicant will offer yoga instruction, eco walks and beach clean-ups. Attached is a copy of the application with supporting documentation.


