

1. Requested Motion:

Meeting Date: October 21, 2013

Approve the Special Event Permit Application for the "Fort Myers Beach Marathon" scheduled to be held on November 10, 2013 and authorize open containers of alcohol at Bayside Park and designated areas of the event, as provided in Ordinance 99-15, contingent upon receipt of a FDOT permit to close Matanzas Pass Bridge, completion of the application, and receipt of an extension of premise.

Why the action is necessary:

Town Council approves all requests for open containers within Town public Right-of-way.

What the action accomplishes:

Allows alcohol served at this event to be consumed by the public outdoors in public and semipublic areas within the scope of the event.

5. Background:

Eident Sports Marketing is hosting the Fort Myers Beach Marathon. Set up for the event starts November 9, 2013 and competition kicks off November 10, 2013 for the event. Sections of Old San Carlos will be closed November 9-10 and the Matanzas Pass bridge closure will occur on the morning of November 10, 2013. Serving and consumption of alcohol at Bayside Park and designated areas of Town right-of-way will be in conjunction with the event. Nervous Nellie's will seek an extension of premises to provide service and consumption of alcohol within the Town public right-of-way. Live amplified music will be included and residents within a 500 feet radius have been notified that this event will include amplified sound and given until October 31, 2013 to respond to the notification should they have any objections. The event will open to the public from 6:00 AM – 4:00 PM on Sunday November 10, 2013, live music will be from 11:00 AM – 4:00 PM Sunday only. Please see the attached special event permit application and supporting documents submitted by Eident Sports Marketing. At this time the application is not considered complete however staff feels that it is necessary to place this special event on the agenda for consideration. The applicant is acquiring the required documents to complete the application but needs more time.



"Town Ordinance 12-04 Sec. 22-8(b)(5) In instances where a proposed special event will be held within 500 feet of residential property and will include any amplified sound, the applicant shall provide notice to such owners and advise them of the nature of the event and the dates and times when the event will be held. The 500 feet shall be measured from the perimeter of the site where the special event will take place and for condominium properties, a single written notification to the condominium association shall be sufficient. The notification shall advise the owner(s) of their right to submit a letter of objection to the Town Manager and shall include the date by which any such letter of objection must be submitted."
