Allows alcohol served within the Times Square area to be consumed by the public outdoors in public and semi-public designated areas within the limits of the Time Square area and provides for funding of entertainment if necessary.

PW and PR staff will provide the set up and breakdown as in years past, which includes the designation of the limits of the open container area.


