The Policy shall list Town of Fort Myers Beach as an additional insured and shall provide that coverage shall not be cancelled or materially altered except after 30 days written notice has been received by the Town.

Proof of the continued coverage under the insurance policy shall provide upon the Town Manager's request, given on a reasonable notice at any time, that the License is valid and outstanding. Any failure to provide such proof shall render the license null and void and of no further use and effect.
