





INTERLOCAL AGREEMENT

This Agreement pursuant to Chapter 163, Florida Statutes by and between the Town of Fort Myers Beach, a Florida municipality ("Town") and the Lee County Board of County Commissioners acting by and through the Lee County Redevelopment Agency (the "CRA), entered into this _____ day of _____, 199___ shall govern certain activities conducted by the CRA within the boundaries of the Town of Fort Myers Beach. In consideration of the mutual promises made herein the Parties hereto agree as follows:

1. The CRA shall proceed with all aspects and phases to conclusion, acceptance and close-out, of that certain project known as the Estero Boulevard Project.
2. Funding for the Project shall be that previously allocated by the CRA for the Project. ~~and such funds as are needed to complete the Project as may be collected from ad valorem taxes in F.Y. 1996-97.~~
3. All Project related CRA staff functions necessary for completion of the Project shall continue unabated.
4. The Local Redevelopment Planning Committee, serving as an advisory body to the CRA, shall remain in place serving as advisor to the CRA. A liaison position shall be created by the Fort Myers Beach Town Council.



for the purpose of aiding communication; providing advice and constructive input to the Estero Island Local Redevelopment Planning Committee and the Town Council.

5. The Parties hereto acknowledge that this Agreement governs only the prosecution of the named Project and any further exercise of powers within the Town by the CRA will require either amendments hereto or a separate agreement. Changes to this Agreement must be in writing and presented first to the Town then to the CRA.
