WHEREAS, the LPA was established in accordance with the requirements of the Town of Fort Myers Beach Land Development Code section 34-111 et seq.; and

WHEREAS, Dr. Frank Shockey has served the LPA as Interim Community Development Director from September 15, 2008 and Community Development Director since December 17, 2009; and

WHEREAS, Dr. Frank Shockey has served the Historic Preservation Board in the same capacity since September 15, 2008 and as liaison to the Historic Advisory Committee since March 20, 2006; and,

WHEREAS, during his tenure serving the LPA, HPB and HAC, Dr. Frank Shockey has provided exemplary service to the Town of Fort Myers Beach.


