



INTRODUCTION:

The Town Council of the Town of Fort Myers Beach is seeking a qualified candidate to serve the remaining term of Seat #5, which expires November 2024, until at which time the Town will hold our regularly scheduled election for seats #3, #4 and #5.

The qualifications are contained in the [Towns Charter, Section 4.01\(c\)](#):

Each member of the council shall be a resident of the town and a registered voter and shall have resided within the corporate limits of the municipality for a minimum of 1 year prior to qualifying for election.

Please note, as of January 1, 2024, all Mayors and Elected members of governing bodies of municipalities are required to submit the *Full and Public Disclosure of Financial Interests* (Form 6) annually. More information on Form 6 and submittal requirements may be found on the [Florida Commission on Ethics](#) website.

Town Council meets typically the first and third Monday of the month, with a Management & Planning Session on the Thursday following the first Monday meeting. Additional meetings may be scheduled as needed.
