

This letter is being submitted to indicate that I would like to volunteer for serving the Town on the Anchorage Advisory Committee.

My wife, Jeanne and I have been Florida residents since '96, and moved to Fort Myers Beach in '99. We also own 60 Nancy Lane on San Carlos Island. We keep our boat, which is a 32' Albin powerboat, on a boatlift at that location. To get to the Gulf from San Carlos Island, I regularly round the south end of San Carlos Island and then follow the channel along side the Anchorage.

As a certified US Sailing race official I spend about 80 days per year on the water officiating sailboat races – which is all unpaid, volunteer work. An example is the upcoming Summerset Regatta, which is an annual regatta held off of Fort Myers Beach for sailboats from Charlotte Harbor to Marco Island. I've officiated sailboat races though-out the country, which has given me access to observing many anchorages.

Additional background of public service includes being on the Kettle Moraine School Board, Wisconsin during the early '90's. Prior to that I was on the City of Delafield Board of Zoning Appeals. I'm also a past president of the Sandarac 2 Condo Association, and a past-commodore of the Nagawicka Lake (sailing) Yacht Club.

Jeanne and I travel frequently. In 2007 we traveled around the world. Countless anchorages were observed during that trip.

I would like to continue to help the Town deal with the Anchorage in such a way that will make the Town a better place to live.
