5. Background:

Ordinance 12-06, establishing the Public Safety Committee, was adopted on August 20, 2012 by the Town Council of Fort Myers Beach. The Public Safety Committee shall address any safety and transportation issues specifically assigned to the Committee by the Town Council for the purpose of the health, safety and welfare of the citizens of and visitors to the Town of Fort Myers Beach. The Committee shall also review, discuss and evaluate the most significant safety and transportation issues within the Town. Ordinance 12-06 states that there shall be no less than five (5) members and no more than seven (7) members of the Public Safety Committee. Each appointed member shall serve for a term of two (2) years or until a successor has been appointed and has qualified.


Staff has advertised the vacancies for the Public Safety Committee and has encouraged interested persons to apply. Currently, one (1) letter of interest has been received from David Zimmerman seeking appointment.

I am writing to you based on information that I received from Alan Mandel regarding the Safety Committee. He indicated that you are seeking members for this committee and I would like to express my sincere interest in serving at some capacity.

Pedestrian Safety has taken on a personal interest for my life based on a tragic accident that took the life of my 5 year old granddaughter in April of 2010. She was struck by a car while crossing the street with her mother, brother, aunt and twin cousins in a crosswalk on a beautiful sunny afternoon. The accident should not have happened and the woman driving the car should not have been driving based on a vision problem that she had. Our family has spent the last 2 1/2 years advocating for Pedestrian Safety in Wisconsin by sponsoring an Annual Walk to increase Pedestrian Safety Awareness.
