5. Background:

Ordinance 12-06, establishing the Public Safety Committee, was adopted on August 20, 2012 by the Town Council of Fort Myers Beach. The Public Safety Committee shall address any safety and transportation issues specifically assigned to the Committee by the Town Council for the purpose of the health, safety and welfare of the citizens of and visitors to the Town of Fort Myers Beach. The Committee shall also review, discuss and evaluate the most significant safety and transportation issues within the Town. Ordinance 12-06 states that there shall be no less than five (5) members and no more than seven (7) members of the Public Safety Committee. Each appointed member shall serve for a term of two (2) years or until a successor has been appointed and has qualified.

Staff has advertised the vacancies for the Public Safety Committee and has encouraged interested persons to apply. Currently, one (1) letter of interest has been received from John Kakatsch seeking appointment.
