

ORDINANCE 05- 09

AN ORDINANCE AMENDING THE TOWN OF FORT MYERS BEACH CULTURAL AND ENVIRONMENTAL LEARNING CENTER ADVISORY BOARD ORDINANCE; PROVIDING AUTHORITY; AMENDMENT TO SECTION 3. COMPOSITION AND APPOINTMENT; SEVERABILITY; EFFECT OF ORDINANCE AND EFFECTIVE DATE.

IT IS HEREBY ORDAINED BY THE TOWN OF FORT MYERS BEACH AS FOLLOWS:

SECTION 1. Authority. This Ordinance is enacted pursuant to the provisions of Chapter 95-494, Laws of Florida, Chapter 166, Florida Statutes, and other applicable provisions of law.

SECTION 2. Composition and appointment, of Fort Myers Beach Cultural And Environmental Learning Center Advisory Board Ordinance is amended to read as follows:

SECTION 3. Composition and appointment. The CELCAB shall consist of not less than five (5) nor more than seven (7) ~~twelve (12)~~ members appointed by the Town Council. The number of members of CELCAB in existence upon the effective date of this Ordinance shall be reduced to seven (7) by attrition. Therefore, upon the resignation, disqualification, or death of a member, or expiration (if any) of a member's term, no person shall be added to the membership of CELCAB until the total membership of this Board is reduced to seven (7) persons. At that time, the normal process of selection of new members shall resume.

SECTION 3. Severability. If any one of the provisions of this ordinance should be held contrary to any express provision of law or contrary to the policy of express law, although not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such provision shall be null and void and shall be deemed separate from the remaining provisions of this ordinance, and in no way affect the validity of all other provisions of this ordinance.

SECTION 4. Effect of Ordinance. The provisions of this Ordinance shall be deemed cumulative and supplemental and shall have no legal effect upon the ordinance establishing the Town Of Fort Myers Beach Cultural And Environmental Learning Center Advisory Board except as expressly provided.

SECTION 5. Effective Date. This ordinance shall become effective immediately upon its adoption.

The foregoing ordinance was enacted by the Town Council upon a motion by Council Member Rynearson and seconded by Council Member Van Duzer and, upon being put to a vote, the result was as follows:
