5. **Background:**

This ordinance has been drafted in order to document and memorialize the history of the CRA that was first created by Lee County and then became the Town of Fort Myers Beach Community Redevelopment Agency after incorporation of the Town. The ordinance readopts and reconfirms the existence of the CRA and includes those statutory items required by Chapter 189, Florida Statutes relating to special districts. A copy of the adopted ordinance will be provided to the State agency that administers all special districts because currently their records do not include required creation documents.

ORDINANCE 13-09

AN ORDINANCE READOPTING AND RECONFIRMING, BY ORDINANCE, ALL PRIOR LEE COUNTY AND TOWN OF FORT MYERS BEACH RESOLUTIONS RELATING TO THE CREATION OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE TOWN OF FORT MYERS BEACH, FORMERLY KNOWN AS THE ESTERO ISLAND COMMUNITY REDEVELOPMENT AGENCY; PROVIDING FOR PURPOSE, POWERS, FUNCTIONS AND DUTIES OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE TOWN OF FORT MYERS BEACH; PROVIDING FOR GEOGRAPHIC BOUNDARIES OF THE AGENCY; AUTHORITY OF THE AGENCY; STATEMENT OF WHY THE AGENCY IS THE BEST ALTERNATIVE; GOVERNING BODY MEMBERSHIP, ORGANIZATION, COMPENSATION AND ADMINISTRATIVE DUTIES; FINANCIAL DISCLOSURE, NOTICING AND REPORTING REQUIREMENTS; METHODS OF FINANCING; CONSISTENCY WITH THE ADOPTED COMPREHENSIVE PLAN; SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Lee County Board of County Commissioners, on July 11, 1990, adopted Resolutions 90-07-21 and 90-07-22 for the purpose of creating the "Lee County Community Redevelopment Agency;" and

WHEREAS, the Lee County Community Redevelopment Agency included various areas of unincorporated Lee County and included the area known as "Estero Island;" and

WHEREAS, the Lee County Board of County Commissioners, on June 17, 1991, adopted Ordinance No. 91-17, which established a Redevelopment Trust Fund and established the base year as 1990 for determining assessed values of property in the Community Redevelopment area for tax increment purposes; and

WHEREAS, the area of unincorporated Lee County previously known as "Estero Island" became an incorporated municipality that is now known as the "Town of Fort Myers Beach" on December 31, 1995; and

WHEREAS, the Town Council of the Town of Fort Myers Beach, on March 18, 1996, adopted Resolution 96-7, and thereby expressed its intent to exclusively exercise all of the powers and responsibilities of the Lee County Community Redevelopment Agency with respect to that geographic area known as "Estero Island;" and

WHEREAS, Resolution 96-7 further requested that the Lee County Board of County Commissioners direct its staff and County Manager to cooperate in the transfer of responsibility and authority for the Community Redevelopment Agency to the Town; and

WHEREAS, on June 1, 1998 the Town Council of the Town of Fort Myers Beach adopted Resolution Number 98-13 establishing itself as the governing board of the Estero Island Community Redevelopment Agency; and

WHEREAS, the Town Council of the Town of Fort Myers Beach, on June 1, 1998, adopted Resolution Number 98-14 and thereby changed the name of the "Estero Island Community Redevelopment Agency" to "the Town of Fort Myers Beach Community Redevelopment Agency" and adopted as its bylaws the same bylaws previously adopted by Lee County as amended through March 13, 1995; and

WHEREAS, on June 29, 1998, the Town Council of the Town of Fort Myers Beach adopted Resolution Number 98-16 which changed the area included in the Town of Fort Myers Beach Community Redevelopment Agency to only those parcels of land on Estero Island from Bay to gulf, bounded on the north by the north boundary of Lynn Hall Park, the commercial area across the street from Lynn Hall Park and the north side of Old San Carlos Boulevard; and on the south by the canal south of Crescent Street from the Bay to Estero Boulevard and the area extending southward along both sides of Estero Boulevard to Pearl Street; and

WHEREAS, the Town Council of the Town of Fort Myers Beach, in adopting Resolution Number 98-16, approved the "Downtown Redevelopment Plan" as the redevelopment plan for the Town of Fort Myers Beach Community Redevelopment Agency; and

WHEREAS, the Community Redevelopment Agency of the Town of Fort Myers Beach filed a bond validation Complaint in the Circuit Court in and for Lee County, Florida in Case No. 98-7386-CA; and

WHEREAS, the Court, in the above-described bond validation case, entered a "Final Judgment Validating Bonds" on November 24, 1998 and specifically found, in paragraph 9 on page 4 of the Final Judgment, that the Community Redevelopment Agency of the Town of Fort Myers Beach is a public body corporate and politic and a community redevelopment agency duly established by the Town Council as the governing body of the Town, and is validly existing under and pursuant to the Town Charter, the Town Redevelopment Resolution and the Redevelopment Act, and is vested with all powers and authority granted under the Community Redevelopment Act; and

WHEREAS, the legal effect of a bond validation proceeding is that a judgment validating bonds is forever conclusive as to all matters adjudicated in that proceeding; and

WHEREAS, since the Final Judgment Validating Bonds in Lee County Circuit Court Case Number 98-7386 specifically found that the Community Redevelopment Agency of the Town of Fort Myers Beach validly exists under the Town Charter, the

Town Redevelopment Resolution and the Redevelopment Act, that finding is "forever conclusive" and is, therefore, no longer subject to challenge by any person or entity.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FORT MYERS BEACH, FLORIDA AS FOLLOWS:

Section 1. The foregoing recitals are hereby adopted and incorporated herein.

Section 2. The Town Council hereby readopts and reconfirms, by this ordinance, all prior Lee County and Town of Fort Myers Beach Resolutions described in the "Whereas" clauses above that relate to the Community Redevelopment Agency of the Town of Fort Myers Beach, formerly known as the Estero Island Community Redevelopment Agency.

Section 3. The purpose, powers, functions and duties of the Community Redevelopment Agency of the Town of Fort Myers Beach shall be as set forth in Chapter 163, Part III, Florida Statutes.

Section 4. The geographic boundary of the Community Redevelopment Agency of the Town of Fort Myers Beach shall be those parcels of real property lying in the area of Estero Island from Estero Bay to the Gulf of Mexico bounded on the north by the north boundary of Lynn Hall Park, the commercial area across the street from Lynn Hall Park and the north side of Old San Carlos Boulevard; and bounded on the south by the canal south of Crescent Street from the Bay to Estero Boulevard and the area extending southward along both sides of Estero Boulevard to Pearl Street. A list of the parcels by STRAP number is attached hereto and incorporated herein as Exhibit "A."

Section 5. The authority of the Community Redevelopment Agency of the Town of Fort Myers Beach shall be as described in Chapter 163, Part III, Florida Statutes.

Section 6. The Community Redevelopment Agency of the Town of Fort Myers Beach is the best alternative because the Town, as a coastal resort and tourist area is deteriorating and economically distressed due to building density patterns, inadequate transportation and parking facilities, faulty lot layout, or inadequate street layout, and can, through the means provided in Chapter 163, Part III, Florida Statutes, be revitalized and redeveloped in a manner that will vastly improve the economic and social conditions of the community.

Section 7. The governing body of the Community Redevelopment Agency of the Town of Fort Myers Beach is the Town Council of the Town of Fort Myers Beach and the membership, organization, compensation, and administrative duties are as set forth in the Bylaws as adopted by the Town Council on June 1, 1998 in Resolution Number 98-14.

Section 8. The applicable financial disclosure, noticing and reporting requirements for the Community Redevelopment Agency of the Town of Fort Myers Beach shall be as set forth in Chapter 112, Part III, Florida Statutes, and Chapter 163, Part III, Florida Statutes.

Section 9. The methods for financing the Community Redevelopment Agency of the Town of Fort Myers Beach shall be as provided in Chapter 163, Part III, Florida Statutes and any other applicable general or special law.

Section 10. The creation of the Community Redevelopment Agency of the Town of Fort Myers Beach is hereby found to be consistent with the adopted Town of Fort Myers Beach Comprehensive Plan.

Section 11. Severability. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section 12. Effective Date. This ordinance shall take effect immediately upon adoption by the Town Council.
